

## Special Progress Report Lisbon High School February 1, 2011

The Commission requests that school officials submit a Special Progress Report by February 1, 2011, which provides detailed responses to the following highlighted recommendations:

1. Confirm the removal of all portable classrooms.

Classification: Complete

Lisbon High School confirms that the portable classrooms have been removed.

2. Provide an update on the status, including funding, of the district capital improvement plan for the high school.

Classification: In Progress

The Lisbon School District Facilities Committee has addressed Lisbon High School's facilities issues aggressively, but has been limited by what can be reasonably funded locally. To address the most extensive and expensive facility needs the school district submitted a request for state renovation funding last fall, and expects to hear the results from the State in the spring of 2011.

3. Provide an update on the renovation work completed during the summer of 2010 to address all previously identified facilities concerns.

Classification: Complete

The locally funded Lisbon High School renovation project that started on June 9, 2010 was completed in the fall of 2010. The improvements to Lisbon High School facilities were: portable classrooms permanently removed, new windows, insulation and siding for 100 & 200 wings, insulated gymnasium roof, painted interior gym ceiling, handicap accessible main entrance, electronic entry access to the entire school, moved the school's Main Office to the bottom floor, the Guidance Office to the old Main Office, the Teachers Lounge to the old Main Office and the art classroom from under the gymnasium to room #104.

## Substantive changes since last special report:

Since the last Substantive Change Report of October 1, 2010 the high school had one substantive change that has taken place, Mrs. Tracy Austin has been elected as the Chair of the Lisbon School Committee (effective immediately) replacing Ms. Prudence Grant.
